**Important League Information!!**

**(1)** Work teams indicated on the schedule in (parenthesis) are recommended to provide a scorekeeper and two line judges for the indicated match. **Work teams are required to provide a minimum of two line judges with one keeping score.** When a line judge is keeping score they are required to hold the score flipper for safety purposes. The penalty for failing to supply a full work team is forfeit of one game and can be extended to three games at the Administrator's discretion.
